**RESOLUTION #2024-13 OF THE LOCAL AGENCY FORMATION COMMISSION OF THE COUNTY OF IMPERIAL APPOINTING THE EXECUTIVE OFFICER TYLER SALCIDO AS AN AUTHORIZED SIGNATORY FOR LAFCO, EFFECTIVE AUGUST 26, 2024**

**RESOLVED**, by the Local Agency Formation Commission of the County of Imperial, State of California, that

**WHEREAS**, AB 2838 known as the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Government Code Section 56000 et. Seq. requires LAFCO to make provisions for its quarters, services, and staff; and

**WHEREAS**, LAFCO relies on the services of the Executive Officer for its day-to-day operations, which include the procurement of staffing, services, supplies, equipment, and office space; and

**WHEREAS**, the Executive Officer shall use independent judgment on how best to secure such staffing, services, supplies, and equipment; and

**WHEREAS**, the Commission on October 23, 2008 passed, adopted, and approved that the Executive Officer shall at all times be directly responsible for LAFCO; have full authority and responsibility for the day-to-day operations; have the ability to secure staffing, services, supplies, and equipment; and has the authority to perform or cause to be performed the necessary repairs, and/or maintenance of the LAFCO owned building & parcel of land (Resolution #A102308); and

**WHEREAS**, the Commission at the July 30, 2024, meeting voted to enter into an employment agreement with Tyler Salcido to be the next Executive Officer for LAFCO; and

**WHEREAS**, the Commission at the August 28, 2024, meeting voted to ratify the appointment of Tyler Salcido as Executive Officer of LAFCO starting August 26, 2024, pursuant to a contract of employment dated July 30, 2024 (Resolution #2024-12); and

**WHEREAS**, the Commission at the August 28, 2024, meeting voted and appointed the Executive Officer Tyler Salcido as an authorized signatory for LAFCO, effective August 26, 2024.

**NOW, THEREFORE, BE IT DETERMINED, ORDERED AND RESOLVED** as follows:

Executive Officer Tyler Salcido is appointed as an authorized signatory for LAFCO, effective August 26, 2024.
