SECOND AMENDMENT TO THE AGREEMENT August 1, 2017

This SECOND AMENDMENT TO THE AGREEMENT ("The Second Amendment") is made and entered into as of August 1, 2017, (the "Effective Date") by and between the Winterhaven Water District, a county water district of the State of California ("District") and Allied Waste Transportation Inc., a Delaware Corporation doing business as Allied Waste Services of Yuma ("Allied") with reference to the following recitals:

Recitals

- A. On July 27, 2011, The District granted Allied an exclusive franchise to collect and dispose of, for a fee, solid waste, construction debris and for providing temporary bin/roll off services for residential, commercial, construction and industrial areas within the District boundaries (the "Agreement"); and
- B. August 13, 2014 the District and Allied entered into the First Amendment to the Agreement (the "First Amendment").
- C. The purpose of this Amendment is to extend the term of Allied's Agreement with the District.

Amendment and Agreement

NOW, THEREFORE, in consideration of the above recitals, the covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge. The District and Republic Service agree that:

- 1. Section 1, B of the Agreement is hereby amended to state that the Term of this Agreement shall expire on July 31, 2020, unless earlier terminated in accordance with the provisions hereof. The Agreement shall automatically renew for three (3) additional one (1) year terms, subject to rate adjustments described below, unless either party provides written notice if its intent to terminate the Agreement not less than sixty (60) days before the end of the current term.
- 2. The rates of service are indicated on Exhibit A hereto, which is hereby incorporated into this Second Amendment and the Agreement as though fully set forth herein.
- 3. Except as expressly amended herein, all other terms and conditions of the Agreement shall remain in full force and effect.
